2. DECLARATION AND ACCEPTANCE OF RESPONSIBILITY

I, the participant or the participant's parent or legal guardian, hereby declare that participation in **Crystal Cup Dance Sport 2026** is voluntary and that I have read, understood and accepted the following terms:

1. Physical condition and fitness to participate. I declare that the participant is in suitable physical condition and health to take part in warm-ups, competitions, performances and other event-related activities. I agree to disclose in advance any injury, medical condition, allergy, treatment or circumstance that may require special attention.

2. Assumption of risk. I understand that dancesport involves intense physical activity and inherent risks, including falls, collisions, sprains, muscular or joint injuries, dehydration and other incidents associated with athletic participation. I freely and knowingly assume these risks.

3. Compliance with the rules. I agree to comply with the Official Rule Book and with all directions issued by the Organizing Committee, Chairperson, judges, medical personnel and security staff, as well as all rules governing conduct, attire, schedules and use of the venue.

4. Emergency medical care. In the event of an accident or emergency, I authorize the event medical staff to conduct an initial assessment and provide first aid. If transportation or outside medical care is required, I authorize the appropriate services to be requested. Medical, hospital, ambulance, medication and treatment expenses shall be the responsibility of the participant or legal representative, unless applicable law provides otherwise.

5. Release of liability. To the extent permitted by applicable law, I release Crystal Cup Dance Sport 2026, the Organizing Committee, venue, sponsors, judges, officials, staff and service providers from civil, administrative and financial liability for injuries or damages arising from the inherent risks of the activity, provided that such injuries or damages do not result from willful misconduct, gross negligence or breach of legal duties attributable to those parties.

3. ADDITIONAL TERMS

6. Personal property. I understand that the organization is not responsible for the loss, theft, misplacement or damage of costumes, footwear, jewelry, phones, money, documents, equipment or other personal belongings inside or outside the venue. I agree to keep my belongings secured.

7. Damage caused by the participant. I accept responsibility for any personal injury or property damage intentionally or negligently caused by the participant, or resulting from failure to comply with the rules or the directions of authorized personnel.

8. Withdrawal or suspension. I accept that medical personnel, the Chairperson or the Organizing Committee may prevent or suspend participation whenever they determine that a risk exists to health, safety, the integrity of the competition or third parties.

9. Minors. If the participant is under legal age, this waiver must be signed by the participant's parent or legal guardian, who represents that they have full authority to authorize participation and assume the obligations stated herein.

10. Scope and validity. This waiver applies while the participant is present at the event venue and during official activities connected with Crystal Cup Dance Sport 2026. If any provision is held invalid, the remaining provisions shall continue in effect to the fullest extent permitted by law.
